To help you understand *how* we all arrived at what is now the most dangerous time in human history and *why* I have had to state “**Who I am**” at the very beginning of this crucial **Statement**: In your Parliamentary library is a 670-page book that the 2008 group of politicians requested from Zenith Publishing. It is called:

THE COMING OF PAKEHA RELIGION

The Spiritual Significance for Maori

New Zealand’s Lost Legacy

I am the author of it; a book that I was “DIRECTED TO WRITE”! Firstly in precise resonance with the purpose for which I was born --- and therefore in strict accordance with those key prophecies by **Ratana**.

Thus, the “*fruits of Ratana’s prophecies*” are in that Work, which has therefore “*finished*”, *completed*, Ratana’s Mission. Being available through the National Library, and its revelation to the 2008 parliamentarians, it was therewith effectively “*revealed to the whole country*”! I also handed a copy to the Apostle leadership at **Ratana Pa**, which means that at least, *symbolically*, it has been made known to the *morehu* of the **Ratana Movement**. It is thus exactly the fulfilment of Ratana’s prophecies which necessitated the third line of the overall Title, vis-à-vis, **New Zealand’s Lost Legacy**.

That which was “lost” Ratana sought but did not find. Something that is “lost” is therefore something “not found”, thus “not fulfilled”. The resultant disparity thereby produces a “gap” --- in this case in critical knowledge for this very time! In order to *close* the “rift”, the sought-after item/thing --- in this case a critical ‘revelation’ --- must be found to “bridge what is missing” so that a full and solid foundation can be anchored and built upon. Any kind of “gap” prevents that.

Further on I have explained precisely that which Ratana “missed” and what that means not just for this land and its people, but ultimately for the whole world.

To further demonstrate the “ordained connection” between Ratana and his prophecies about me, here is a further key one that the Prophet stated in 1936. In terms of its *foretelling prescience* it is precise, for ‘**THE COMING OF PAKEHA RELIGION**’ was published not long before Helen Clark became Prime Minister.

“You have all heard and are familiar with the word that says: ‘Night-time has passed, the new break of dawn draws near’, there is a day unfolding when you will see two towers standing on the Mount of Olives, and at that time you will see a woman rising up from the Labour Party who will become prime minister, and then you will know you are at the doorway, not nearing it, but actually at the doorway ...”

(T. W. Ratana, 11th November 1936 at the Mount of Olives, Ratana Pa, “Ratana Revisited”. Keith Newman.)

The prophetic power of Ratana is well-demonstrated here, for to “see” Helen Clark’s ascension to become Prime Minister many decades in the future is testament of his Calling to that post.

So: If we were “actually at the doorway” when ‘she ruled’, then the time since has surely shown us that we have *all* well and truly gone through it. The worsening plight of more and more global societies clearly testifies to that hard “Truth”!

Therefore: In terms of WHY such a Book was “directed” to be written for this land and its peoples in the first place, and why for a *second* time it is brought to the attention of the politicians of this land, specifically to “you” elected in 2020; it is precisely because that Work --- by virtue of its Source and thus commensurate content --- at its publication *clearly signalled* that the future would not, *could not possibly be*, a time where the human race would be “showered with rose petals”.

The unfortunate irony of this **Statement** in terms of its *purpose* is that had Ratana *found* what he was “looking for”, he would have proclaimed it to the Nation, and you would *all* very definitely know about it today. It is therefore highly unlikely that I would have had to send you this **Statement** in its “Directed Format” in 2021 or, indeed, *even have to be here* to fulfil this “Directive”!

However, in accordance with the prophecies about this land and its High Purpose, the Mission *could not be left unfinished*. To therefore complete it, one of **Maori** descent was still required for the task. In terms of the well-known “fighting spirit” of the **Toa** --- which a **STATEMENT** such as this requires --- that person, me, had also to be a **Soldier**, and one who had to necessarily experience multiple **Tours of Duty** in “harm’s way”. That kind of intense and prolonged experiencing wrought the degree of discipline necessary to *later* receive --- *without questioning it* --- *all* that I was *directed* to write!

Prior to self-publishing **THE COMING OF PAKEHA RELIGION**, I petitioned for an answer as to what I should reply when, in *my* words; “*the slings and arrows come against me*”!

In its sublime simplicity, what I received far *exceeds* any kind of so-called *human wisdom*!

That singular “message” is therefore also necessarily addressed to you who in 2020 sought political power and authority, and the *ostensible right* to govern this land and its peoples! It is profoundly simple:

“If I do not tell you this, who is going to?”

Despite the fact that you will not hear the essential Truths contained in this **Statement** from any other person, it is very probable that at least most of you who currently occupy the “corridors of power” in this land will mock both the **Message** and the **Messenger**!

True *wisdom* would say, however: Heed the **Message**, not the **Messenger**! A “lone voice in the wilderness” I perhaps may be, but the very content herein stands in its own unassailable position as, by direct association, do I.

In the end it matters not how it is received, for we are of the generation that is bearing clear witness to the collapse of more and more once-stable and revered “human” institutions, to failing societies, and to a rapid acceleration of the terrible and inexcusable destruction of earth’s eco-systems.

A NECESSARY ‘COMMENSURATE’ NOTE:

The manuscript of **THE COMING OF PAKEHA RELIGION** was reviewed by Bob Ross of Tandem Press. (He published “Once Were Warriors”).

He wanted to publish but was somewhat unnerved by its depth and content --- which was nonetheless “directed” to be so!

He sought endorsement *for* the book from a Maori academic (unnamed). The review notes condemned it and stated: “*Do not publish this book*”. The same occurred with Harper Collins with a *different* ‘academic’. Again: “*Do not publish this book*”. Reed put it into their “too-hard” basket!

Yet, to all Maori academics ‘out there’ then and now --- and certainly to all Maori politicians and ‘leaders’ --- as Ratana clearly prophesied, it was *from* a Mangai (anointed mouthpiece), “*that you will not be able to suppress*”.

In this day and age of strident and vociferous calls for the “right to free speech”, why would ‘Maori academics’ be afraid of the Work “hitting the bookshelves”?

I certainly know why! History ever attests to the fact that the greater bulk of the human race has *never* wanted **Truth**!

Whilst all may say they do: In truth, every person, every group, every culture, *every religion* --- **every political party** --- wants “their narrative” to be that so-called “truth”! Narratives that must never be questioned, let alone challenged. A common remark: “*I have my own truth; I don’t need any other*”. In terms of we billions on earth, that is a lot of ‘different truths’! In short: Everyone wants the world to be their way!

Despite such obvious human idiocy: As it was originally Ordained to be for *all* races and Nations, from both the Missions of Ratana and what I was tasked to find that Ratana did not, the *next step* into the knowledge of **Final Inviolable Law** for *this land* and its peoples *has been fulfilled*.

Of course, *how* the “collective” of *you and* the populace of New Zealand relate to it is effectively taken from my hands, *but it cannot be changed!* Just as Ratana could not change his life’s purpose, neither could I.

If we extrapolate to a sure assertion of **Who** Ratana “missed”, *that person’s* Especial Life on earth included the time-frame of the two most destructive wars in the history of mankind. From just that fact alone, you should not need me to tell you **Who He** was!

Despite Ratana’s great knowledge of the Bible and the formidable talents *conferred* upon him, in particular his incredible prophetic capabilities, it is puzzling that he was not able to *spiritually/intuitively perceive* the profound **Event** that occurred during his lifetime. For that is what he was looking for, the *something else*, the *something yet to come*! That is why Ratana’s non-recognition of **Him** was such a great tragedy for this Nation.

Now in 2021, one unforgettable year after the great 2020 year of a world-changing “Pestilence” that is still continuing its rampage, the many global problems already clearly evident *before that* are now *far more dire* than previously forecast.

In terms of the major one the world currently wrestles with; the collective human agglomeration of Planet Earth has focussed a large amount of its resources and energy on the goal of ‘eradicating’ the Covid 19 “**PESTILENCE**” in the belief that if and/or when that goal is *fully* achieved, *the world* will once more be an ostensibly “good place”! (Even the funeral of a ‘**Prince of the Realm**’ had to bow to Covid 19’s unyielding rule!)

In truth, our world has not been a “good place” for many decades. This is because each year that passes “prepares” the foundation for the next one to follow. The downward trend is clear to see. So in the first place, the problem for the human race in 2021 is *not* actually the Coronavirus at all! That is just a symptom --- albeit a deadly one --- of what is “really wrong with us”!

For even in the face of such a deadly killer, political leaders cannot seem to unite to *equitably share* the various vaccines available. Whilst politicians of the First-world Nations haggle amongst themselves over their “greater-share-by-right” position, politicians of the poorer Third-world can mostly only finger-point and blame!

NO! The ultimate reason for *all* of our problems has been our collective, continual “attitude” to *Urgings*, *Admonitions*, and even *Commands* gifted to all peoples and races over thousands of years by *very enlightened men*--- ultimately for our benefit --- so that we might live in at least *some measure* of peace and harmony!

(Do not misconstrue what is stated here as “*religion*” or something akin to it, for *the above reality* has *nothing whatsoever* to do with any kind of “human faith-belief system”. In clear truth, in 4K high resolution “religion” --- *as it presents itself today* --- has become a **curse** for global humanity.)

That is our *today-tragedy*, for through the Ordained Missions of those *spiritually-enlightened men* I have only alluded to at this point, all races and peoples were gifted with the crucial and indispensable **Laws of Life!**

Unfortunately, we, the various *followers* of those Teachers, retranslated, reinterpreted, and even *knowingly distorted* the original teachings --- *all of which actually taught the same Truths* --- to end in this 21st century with uncountable numbers of “religions”.

With no two in agreement anywhere, what the world now suffers from is a very large *suppurating cesspool* of **religious** intolerance, hate and bloodshed on a scale difficult to logically comprehend, all of which now produces fear across the globe.

You politicians --- whose role is, *or should be*, to legislate “Correct Law” for the benefit of *your* people --- should ask yourselves how and why those great Teachings have been so grossly distorted as to finally end up with global societies that are becoming increasingly “ungovernable” and wracked with every problem imaginable!

If you do not know the answer to that critical question, or perhaps not even thought about it, well, in the *first* instance, it is *actually in this land* --- *specifically featured on the Prophet Ratana’s Temple* and on the banners and flags of his **Movement**.

What you therefore need to know is that the clearly identifiable “Sign” on his **Temple** ultimately provides the actual *answer* to the dire state of global humanity. However, in order to *fully understand* what the Appointed Prophet for Maori and New Zealand *more surely did* --- otherwise he would not have placed that especial sign on his Temple at the outset --- in this case that vital answer will *not be found* in present-day educational parameters. Neither will it be found in what now features *too pervasively* in New Zealand society --- ‘**Maori Customary Law**’!

Therefore, along with what more and more scientists are now referring to as “**Tipping-Point Earth**”, the critical question that must be asked here is twofold. One obviously concerns science and what its findings, products and

experimentation has either gifted to us, or cursed us with! The other must necessarily be directed to the world's key "decision-makers" --- obviously, the politicians!

For irrespective of political ideology, even *ostensibly* altruistic social aims, the failing state of global societies *today* can be *directly placed* at the *collective feet* of *generations* of uncountable numbers of various *types* of "politicians" and lawmakers --- including Emperors and dictators --- **all of whom** believed that *their* decrees/legislated laws were best for their peoples and societies.

Yet, through thousands of years of "political machinations", incrementally and inexorably, we have arrived at a point in time where that notion is clearly revealed as *fatally flawed*. In a word: **Wrong!**

Of course, only the most *courageous* among politicians would even *deign to admit* that *that* reality really does reflect the state of human societies today. Even during the madness of the last days of the Trump saga, the incredible egos of certain myopic 'politicians' would not bend to accept the obvious.

THE PROPHET RATANA'S TRUE MISSION

Now, in precise concert with the above considerations, you of the many New Zealand politicians who have attended celebrations at **Ratana Pa** for the Founder's birthday, even if only to curry political favour; have you ever asked yourselves why there are ***no*** Maori carvings or motifs on the **Ratana Temple**? They also do not appear on the inside of it. So why would a man born into a strong Maori *psychic* environment decree that such carvings were not to be displayed thereupon?

In concert, the further key question for you: **Why, in their stead, did Ratana decree the "Whetu Marama" as the primary Symbol for his Church and Movement?**

Commensurately: How did a man who had *relatively* little education *arrive* at the *recognition* of the *critical importance* of that "*primary sign*" now on his **Temple** in this *key* land of **New Zealand**?

Clearly, Ratana recognised that if a people and Nation were to *advance* in knowledge and harmony under **High Guidance**, then symbols inherently associated with Knowledge far higher than just 'customary law' or 'lore', would decisively "anchor" that level of "essential knowledge" in the land. In addition, be the foundation for the **Spiritual** thus *primary part* of his **Mission!**

That fact precisely reveals *why this land and its peoples* --- Maori and Pakeha as the foundation, then *all others* who have *sought residence* here --- were always meant to have *collectively fulfilled* a High Purpose!

The oft-quoted but sometimes contentious proclamation: "*He iwi tahi tatou*", "*We are one people*", was supposedly first stated by Governor Hobson during the signing of the Treaty of Waitangi in 1840. According to Dame Joan Metge the phrase, correctly translated, in 1840 would have meant: "*We two peoples together make a nation*".

I, for one, absolutely concur, simply because it makes eminently-logical sense. In terms of that ordained "nation-building" potential, Ratana began what should have evolved to become a complete **Spiritual** transformation of New Zealand society! **He** thus knew *why* the "**Whetu Marama**" had to be featured on his Temple, and not traditional Maori carvings, for his Ordained Mission needed a *Higher level of Knowledge* for its fulfilment!

If we now break down his Emblem to the three key parts of the whole, an interesting connection emerges. It is well-known that, together, the *five-pointed star* and the *crescent moon* is the signature emblem of **Islam**.

The foundation of Ratana's Mission, however, was **Christianity** --- *New Zealand's founding religion!* Though for him and his Movement, it could not be as it had evolved from its inception all the way to the 20th century. For what arrived in New Zealand with the missionaries was a doctrine of primarily *Church ritual*, for centuries already rigidly locked in stone. Indeed, history well-testifies to the fact that all the three monotheistic religions of **Judaism**, **Christianity** and **Islam** underwent continual revisional changes!

Ratana's use of the "Whetu Marama" and its symbolism is significant due to an especial *connection* that *both* the religion of **Islam** in **Arabia** under the Prophet **Mohammed**, and the **Ratana Church/Movement** in **New Zealand** under the Prophet, **Ratana**, both possess! That *connecting element* is the **Archangel Gabriel** --- the primary guide for *both* Prophets!

Whilst that is major, the most *important* symbol on the "**Whetu Marama**" is that of the **A** and the **O** --- the **Alpha** and the **Omega** --- the **Beginning** and the **End!** For the very *foundational-essence* of both the symbolism and meaning of it is that of **Inviolable Creation-Law Truth!** And that represents the key point of this **Statement** for this 21st century of collapsing global societies!

(The critical link, however, will be elucidated in the closing pages!)

So: Why Ratana and the Maori race? The answer, though simple, would probably not sit well with the "Christian Church"! Nonetheless, the arrival of Pakeha missionaries set in place an exceptionally strong acceptance of Bible Scripture in Maori. So much so that *they* built most of the early churches, not the missionaries. Therewith was ordained the true *spiritual* purpose of the Maori race.

It was not because they were already a "spiritual people". They were not. In fact, they were far from being so! For if they really were, then, quite logically, *Ratana would not have had to be sent to them!* You cannot *eat people* --- like my cannibal ancestor, **Hongi Hika** --- and somehow claim "great spirituality"!

No! It was simply because the Pakeha Church had little true spiritual life left in it, just mostly tradition derived from more than a thousand years of intellectually dissecting and reinterpreting the True Message of the Bible. That is why Ratana recognised that he could not stay with the Anglican Church, and why his plea to the effect: “*Please save us from intellectuals!*”

So, by **Higher Ordination** and solely under Ratana’s Ordained mantle, the “new blood” of a very different kind of people was Called to Service! Not to “own” the land air and sea, but to lead this small Island Nation at the bottom of the world into the *direction* clearly shown; that which Ratana established. For it is ludicrous to think that his seminal achievements could somehow be those of a “champion wheat-stacker”, or the “local bookie”! No! His work and accomplishments could not possibly have been realised without *exceptional help* from his **Guiding Source**, well-documented in his life.

Now, a hard-hitting reality check! Notwithstanding the incredible works Ratana produced that were and still are critically essential for this land and its people, it is nonetheless vital to understand the far greater potential that was *not* realised; that there was meant to have been a far deeper aspect to his Mission that is *not known* --- certainly not by the Morehu. A key member of the Church hierarchy at Ratana Pa was made aware of that fact by me in person but, as is the case with most “followers” of Prophets, was seemingly not passed on to the rank and file!

Whilst all that may seem far-fetched, and you may well ask --- “*how would he know*”? --- certain elements in Ratana’s life actually point to what is the third line in the overall Title of **THE COMING OF PAKEHA RELIGION** --- vis-à-vis: **New Zealand’s Lost Legacy!**

To repeat: What was lost --- or “not found” --- was Ratana’s non-recognition of the critical *connection between* two prophecies/messages of 1918 *and* what he was searching for in 1925. The first vision from 1918. (From Keith Newman’s “Ratana Revisited...”.)

“I, Ihoa, have heard the cry of the people, this is the reason why I have come to you, the Maori people, to be my footstool upon the earth. Go forth and unite the Maori people under me, Ihoa, heal them in all their infirmities, in the name of the Father the Son, the Holy Spirit and the Faithful Angels.”

The Maori race in 1918 were suffering many illnesses. Indeed, it was thought by some then that the race would actually die out, hence the *power* conferred on Ratana to heal the people and destroy Tohungaism --- to which Maori had long bowed --- and thus **save them!** The second in similar vein, but stronger.

‘I am the Holy Spirit. I have visited the scene of the war which has recently raged in Europe. In my travels I have found that the whole world has forgotten me. I have looked all over for a place to establish myself, and to ensure that God will again be truly known and accepted in the hearts of men. That is why I have come to you, the Maori people. I have investigated your behaviour and found that you have sinned also. You have sinned in that you have bowed to Tohungaism and other Maori gods. However, despite these misdemeanours, I see that you have not forgotten the Lord Jehovah, the Father and Creator of Heaven and Earth. He has this day heard your call.’

Those are perhaps the most important prophecies/messages given to Ratana! Whilst gifted to Maori, and thus New Zealand, they did not derive from the Christian Church or its religion!

If you in the Beehive wish to fulfil your political destiny in the *only right way*, then you need to gain real understanding here! It would be a serious mistake to place any kind of religious connotation on those “messages to the Prophet”, thereby deeming them not relevant for a supposedly more sophisticated populace in 21st century New Zealand --- for the very *opposite* is the case!

For in those two prophecies is an absolute and *unbreakable connecting link* between them and what in the 1925 American Tour Ratana was searching for. “*Ratana was looking for something he could take back to the Maori people*”, and whilst he had struck major deals with Henry Ford and American express, he turned them down. He was looking for “*something else, something yet to come.*” (Ratana Revisited. P 538. Emphases mine.)

An open cheque from Henry Ford for Ratana to be the South Pacific distributor of his motor vehicles most anyone else would have snapped up. It is a tribute to him that he was not prepared to be just ‘anyone’s man’. That was not his Mission.

The key question here is: In 1925 what was he looking for that was *yet to come*? Whilst that is all *fully explained* in **THE COMING OF PAKEHA RELIGION**, until it is *recognised* and *embraced* by more than just “the few” in this land, it is effectively still something yet to come! That is **New Zealand’s Lost Legacy!**

(To repeat: The revelation of what was *not found* in his lifetime is stated in the closing pages of this Statement!)

For all of you politicians, especially, 2021 is a critical, watershed year for the human race! Therefore the *recognition* of that **Revelation** ultimately clarifies two *crucial outcomes*. One is the *very purpose and direction* that this Nation and all its diverse peoples --- but especially Maori --- *should have taken*, and thus *fulfilled*! To our serious detriment: **Neither Maori as a united people nor the rest of the populace did so!**

The other, for this time of rapidly-evolving “global transition” into a new and very uncertain future for the *whole* of the human race --- which we *all* know to be true now --- encompasses the *ultimate reason* why we of the human race

are assailed more and more frequently by crises of one form or another: the current *major one* being a very clever, constantly-mutating, *pestilential* killer.

Therefore: If you --- like more and more *everyday people* now --- truly wish to make sense of the Coronavirus ‘Pestilence’, our rapidly deteriorating global societies, the madness of habitat destruction of our once-pristine earthly home to the grave detriment of our precious wildlife just for obscene profit --- to name just a *few* of our *many* problems --- then *that* is what you seriously need to engage with.

For *only with the commensurate recognition* of what Ratana *did not find*, might you politicians of this land then perhaps *begin to perceive* how you need to frame what would *then be correct* legislation --- **for New Zealand!**

Despite the reality that major decisions made in one part of the world can detrimentally affect every other part, what the rest of the world does has to be *their* concern. The unique history of this Nation --- especially in terms of its ordained line of prophets culminating in **Ratana** --- calls for it to *not travel* the same paths as other peoples!

However, as an aid and therefore shining example to the rest of the world, you can get it right here *first* and thus lead by example whilst the global spotlight for our good Covid 19 work is upon us right now.

TRIBALISM AND THE TREATY

The book --- **THE COMING OF PAKEHA RELIGION** --- was *directed* to be written *primarily* to awaken the Maori race to their *true* “spiritual purpose and destiny”! In addition, to the fact that their “Ordained Prophet” was sent to direct them to *leave tribalism behind* and become one people --- the very same process which has occurred with other peoples of the world who are now “one Nation”.

In some cases, that *necessary transition* was directed by **Truth-Bringers** of the particular race into which they were born, and who guided the transitional process over the period of their lifetime.

The vast difference with Maori is that *whereas* most races took many hundreds of years to *evolve from* tribal groupings, here in New Zealand under the *authoritative mantle* of the **Prophet Ratana**, that necessary “severing of ties to tribalism” --- at *his* Call could have taken place for *every* Maori in virtually *an instant of time in the 20th century!*

Of all peoples that have ever been, *only* Maori --- *at one stroke* --- were *gifted* that chance. It is testament to the authority of **Ratana** that of a Maori population of somewhere near 57,000 at that time, around 34,000 flocked to his “Ordained Spiritual Banner” to sign his Covenant to leave tribalism behind.

The rest --- *many unfortunately influenced by Maori politicians actually opposed to Ratana’s Mission* --- wrongly stayed with “tribalism”, to the ultimate detriment of this blessed land and what should have been a true **Spiritual Legacy** under the umbrella of **Higher Law!**

Not so long ago, Sir Peter Tapsell --- clearly more far-sighted than most ‘tribal leaders’ --- tried to steer “Maori thinking” away from “tribalism” and work towards regional organisations, and thence to a “Pan-Maori Nation”. Instead, in its place is now a firmly established, *legislated industry*, almost wholly centred on grievances, often toxic in their vociferous nature, and driven by the very thing that should have long since been let go --- “tribalism”. Deeply engrained with all its attendant “cultural emotionalism”, particularly in “ancestor retention”, the necessary “spiritual recognition” to let it all go will probably come too late!

By its very nature, the refusal to let go “tribalism” by the greater majority of Maori provides the very *coercive aspect* that both *drives* the “industry” and, concomitantly, *influences* politicians. Whether overtly or covertly matters not. Indeed, such is its *entrenchment* in the *political* landscape, that it is difficult to *ever* envisage a day when the job of the Waitangi Tribunal would actually end.

For whilst there have certainly been, and perhaps still are, genuine grievances outstanding, the very *reality* of the Tribunal has wrought a “splintering effect” where smaller factions separate from the main tribal groupings to seek their own “specialised” claims.

MAORI CUSTOMARY ‘LAW’ AND “OWNERSHIP OF WATER”

To reinforce what I am saying, one *blanket claim* currently in the “pipeline” stands so far outside the parameters of what would be regarded as *reasonable*, that it actually *defies* logical belief. And that is the claim to “ownership” of *all* the *water resources* of this land. Does that include the glaciers too, and therefore the *falling snow* that is *their* source? ? ?

Under the Mantle of the **Very Highest Law**, ‘Maori Customary Law’, or *lore*, does not possess --- *can never ever possess* --- any kind of *inalienable right* to ‘own’ that life-giving resource!

For if Maori think they can claim *that*, then they must *first claim* “ownership” of the very **Source** of that water --- the whole *hydrological cycle* of the **Forces of Nature!** For it is the actions of sun, wind and evaporation that produces the falling rain. Who in the whole of the human race would dare have the temerity to claim all of that?

Actually, we can identify at least two entities here. One is the destroying greed of American-style Capitalism, the other is the Maori race!

What you urgently need in your debating chamber is a very large copy of the great Chief Seattle’s address to Governor Isaac Stevens who, on behalf of the U.S. Government, negotiated to *buy* part of the Duwamish people’s ancestral land.

Rightfully regarded as “*the most profound address on the environment ever made*”, Chief Seattle explains the *higher meaning* of land, air, and water! It is certainly not about *ownership* of a resource vital to *every living thing on this planet*. For now, just one sentence of clear *wisdom*! (Emphases mine):

“If we do not own the freshness of the air and the sparkle of the water, how can we buy them?”

Despite all the *buzz words* constantly being thrown at us as Maori being *kaitiaki* of New Zealand’s eco-systems, in *this case* the whole cultural paradigm of Maori does not get anywhere near the Native American peoples *far greater reverence* for *their* natural environment.

For despite various ethnic peoples regarding themselves as a global “brown brotherhood” ostensibly possessing a high measure of “spirituality”, what has never been fully understood by Maori or Pakeha is the huge and fundamental *difference* between *how* Maori and Native Americans, respectively, viewed the “Forces of Nature”!

Clearly documented by early chroniclers: Whereas Maori *feared* their environment, needing to offer *karakia* for *protection* before entering the forest to hunt --- Native Americans, in stark contrast, *revered* their environment, offering *constant thanks* for all that the land gave them. (Even today, the forest and the night are still feared by many Maori.)

(From a spread of relevant publications, those starkly-contrasting positions are *clearly detailed* in the commensurate Chapter in **THE COMING OF PAKEHA RELIGION**.)

So: If the claim for “ownership” of New Zealand’s water resources were granted to Maori by what would in this case be a very myopic and totally misguided Waitangi Tribunal panel, the resultant *ongoing* and obviously *very large revenue-stream* thus generated would serve to line ‘privileged Maori pockets’ on a forever basis! For Maori would surely also demand all the Water Treatment plants as well!

Business, industry, and even ordinary households would be held hostage by what would potentially be *tyranny* by another name, for then no water source or resource would be off-limits for revenue-gathering. In the end a very bad outcome for the whole country, and one *ultimately* imposed upon us by you in the Beehive! Under the *aegis* of the **Highest of Law** that would be “a step too far”!

Quite unbelievably, the very idea of even *proceeding* with such a claim is nothing short of *cultural arrogance*, with plain *greed* being its clear companion!

THE TANIWHA: “Guardian” of Waterways

For all you politicians in the Beehive: A necessary explanation about the pointless “Taniwha” in Maori ‘lore’. Firstly, it is vital to understand that “Nature” has a powerful living aspect to it. It is known scientifically as the “Gaia” hypothesis. Otherwise, of course, nothing on earth would grow! Ancient cultures were more aware of that “living energy” than most modern societies today, so at an early point in their histories “produced” entities of one form or another. Some were benign as aspects of Nature, others brought into being through fear.

In the case of the latter, the process starts with the thought. It then proceeds to becoming a belief, and then to it being *formed* as an actual *entity* in the *psyche* of the culture. It is thus given ‘life’. From Europe the “werewolf” of Southwestern Germany is a well-known example.

The *fear* of the “thing” then plays a dominant role in the culture. In the case of the “Taniwha”, certain pools and waterways can thus become places that must be avoided. Karakia ‘appeases’ the ‘monster’ and keeps everybody more or less safe. That is the Maori cultural view.

In blunt Truth, the **Taniwha** was *never formed* at the inception of **Creation**, any more than the werewolf was. They are both *psychic productions* of the races that have given them “life”. They serve no useful purpose and *should never have been brought into being in the first place*. The Taniwha is held in place here because like so much in Maori thinking, is *wrongfully* regarded as being somehow a “spiritual part” of the culture! But it is not.

In the final analysis, such beliefs are actually a bind of “*cultural emotionalism*” to things just “psychic” only! Thus the *lowest end* of the spectrum of the much-vaunted “*three kits of knowledge*” in Maori ‘lore’.

For the very word and concept --- **Spiritual** --- means the Higher, Ennobled Aspect of who and what *we humans are supposed to be*! The Taniwha does not fit, for it, along with *all* psychic productions, are little more than just a *pretence* to so-called *great spiritual knowledge*. The *ostensible sacredness* of “taniwha lore” has even held up the construction of bridges across waterways --- at great financial cost to us all.

TAKAUERE, the **Taniwha** of **Lake Omapere** in Northland.

For your elucidation: Here is the *true story* of *how* a Taniwha can come into being! In the attached addendum of “**Who are You?**” is the Tatai/Whakapapa of my “earthly” connections to **Ngapuhi**.

On the bottom line is the name of a male child, “still-born” to my Grandmother, **Meri Hohepa Te Wharaupo (Hita)**. So that the ‘soul’ can continue its journey, “still-born” offspring were given name. In addition, whilst at death the ‘once-living’ were *buried*, “still-born” babies were placed in water.

As was customary *then*, the “child”, whose given *full name* was **Takauere Te Putahi Hita**, was released into the lake. **Omapere** was an important eel fishery, and the action of placing “him” in the reeds disturbed a very large eel which, as they do when alarmed, reacted with explosive power and swam into deeper water. In a relatively short space of time, the “true story” morphed into “legend” --- of the **Taniwha, Takauere!**

In truth, therefore, and even though “still-born”: **Takauere was my Uncle!**

Those are the kinds of wrong beliefs intricately connected with Tohungaism. In direct concert with the relevant Bible Scripture which points out that: “*We fight not against flesh and blood...*”; --- in order to *free* Maori from them, Ratana was given the power to *destroy* Tohungaism, which he did.

That is why, *politicians*, the life of this man should be part of *every* school curriculum, to help free *everyone* from things that simply do not resonate with **Creation-Law Truth!** Unfortunately, a new and strange Maori renaissance has foolishly resurrected that “stuff” and labelled it all “spiritual”. From a lack of knowledge that would allow true and necessary “discernment”, too many Pakeha either buy into it, or are insidiously coerced to accept it.

In the current direction that even some of you Pakeha politicians are taking this country, it is a tragedy! Yes, I said **Tragedy**, for all such “spiritually-wrong beliefs” ultimately deny the very reason, place and **Mission** of New Zealand’s Ordained Prophet: **Ratana!** So like the rest of the world we, too, head off in a completely false direction!

Thankfully, however, along with so much other human “dross” that does nothing more than produce angst and thus serve no useful purpose, the increasing and unrelenting **Pressure** of the **Highest of Law** will, at its rapidly approaching and appointed time, simply *sweep it all away*.

In direct concert, since Maori Customary Law permeates so many facets of life in this land and now cannot be separated from “the Treaty”, have any of you in the Beehive ever asked yourselves why, in this 21st century, we still believe we *need* a Treaty?

If you have not or are too ‘politically afraid’ to even broach the notion then, from the perspective of inviolable **Higher Law**, the reason why we believe so is because, *as a people*, we do not possess sufficient “**SPIRITUAL MATURITY**” to “**Not Need It**”!

That necessary level of “maturity” in the end can only derive from the recognition and embracing of **The One Law** which, from the very beginning, was decreed to be so for *all* peoples of the earth! In truth, we of the human race are so far from even recognising the *criticality* of that **Highest of Ordinations** that it seems pointless to even state it here. Nonetheless, I am “directed” to do so!

If you were to conduct a survey of the rank and file of New Zealanders, you would find huge disquiet over the whole business of *never-ending* “Treaty Settlements”. Few will speak out publicly, of course.

The problem: Too much P.C., too much ‘customary law’, and not anywhere near enough **CREATION-LAW TRUTH!**

Maori Customary Law, like the “customary law” of all other peoples; in its cultural knowledge-quotient, cannot even begin to approach such “Ultimate Knowledge”. For, by comparison, the “customary law”, or “lore”, of *all* peoples is really only concerned with customs and traditions etc., and there stands its commensurate ‘place’!

MAORI PARTY POLITICIANS

Therefore: To you politicians of the new “Maori Party” with a new “human political mandate” to promote what you will no doubt believe as being a better direction for Maori than what has been --- *if you have not done so* --- from the books currently available, you really need to study the life and times of *your* Prophet, Ratana, sent to Maori in the first instance.

However, only from “**THE COMING OF PAKEHA RELIGION**” will you *fully understand* the High Purpose of his Mission, thus what he was *further directed* to set in place for you *and* this country, but unfortunately did not. From it, also, is explained the *true Spiritual meaning* and thus **Higher Purpose** of that contentious reality: **COLONISATION!**

For despite the fact that **Colonisation** did bring in its train previously unknown diseases and land loss to *all* ‘colonised’ peoples, its **Ordained** and thus *ultimate purpose* has never been *fully recognised* by colonised peoples *across the globe*. Under Ratana’s guidance, however, of *all* colonised peoples, it was the purpose of the Maori race *to make that key recognition* and thence help others to the same “acceptance”. That, too, would have fulfilled another of Ratana’s prophecies for Maori, stated in 1924:

“Although the faith was brought here by other people, *it will be us who will take the real faith to them*, because the real faith has been established among us the Maori people.”

This **Statement** therefore *proclaims* to you in no uncertain terms, that *only with* the recognition, embracing, but especially the *enacting* of the **Higher Laws** that came *with* **COLONISATION**, could Ratana guide the Maori race according to his **Ordained Mandate!**

In this new age of Maori renaissance, however, non-acceptance of “spiritual realities” deriving from “historical events” will mean that Maori --- like the rest of the human race --- will continue on the same downward path of inexorable societal collapse that has long been prophesied. In blunt Truth: Your “customary law” will simply “not cut it”!

Under Ratana’s guidance, this land and its peoples were meant to have been the right example for others, hence his Call to Maori in the first instance! But it did not happen!

In concert, what you therefore *all* need to know is that his Mission was a *continuation* of the *ordained* Missions of the many **Teachers** and **Prophets** of other nations and peoples who had long preceded him. **Ratana**, however, arrived

at a time in history where *terribly wrong* decisions that *had begun* to insidiously affect the reasonably stable institutions and social orders of European Nations could have been “turned around”, but were not.

The **Anzac Day Commemorations** in New Zealand and Australia bear indisputable witness to that fact. Tens of thousands killed and maimed in just our two countries alone because of the assassination of one man a long way from our shores. Rather than seeking resolution through dialogue, the terrible pride and egos of European *politicians* who would “lose face”; instead, whipped up nationalistic jingoism and sought war as the “first option”. Pride and ego, destroyer of men and nations.

True **Spiritual Mana** and **Strength** lies in the “**Power of Humility**”! And *genuine* humility --- or humbleness --- is *never* subservience!

Whilst we acknowledge that nations can become stronger through adversity and sacrifice, nonetheless; in that aftermath of 60 million dead and the end of empires and crowns, in the case of the assassinated Crown Prince it may have been better for those same *politicians* to have remembered the comment of high priest Caiaphas at the trial of Jesus. In that case, however, a singularly arrogant directive that condemned the most innocent of all to horrific torture and then to His subsequent “murder” --- *still yet to be paid for!*

“It is better for one man to die than that a whole nation should perish!”

The “Great War” provides us with perhaps the best historical example of ‘*Decisions equal Consequences*’ and ‘*We Reap what we Sow*’, unlike the Second World War where a monstrous evil had to be defeated.

As I have pointed out, the time-frame-connection of Ratana to the *era* of the Great War and its immediate aftermath has direct resonance to **New Zealand’s Lost Legacy**. The critical nature of that *lost connection* not only by Ratana but by virtually the whole of the human race, in its actual outworking *in the present* can be seen in extensive and *increasing* deadly social disorder that has developed to become the new norm in many countries! Thankfully, at this time at least, we are spared that insanity!

In terms of *how* the *political regimes* of the countries affected produce the legislation designed to curb, control, or even *appease* increasingly restless factions of their populace; in the end all we see is a kind of carousel effect. For the political decisions arrived at are invariably *in-the-moment*, *short-term* attempts to try to resolve the given problem. The very fact that social unrest is sharply on the rise globally attests to the stark fact that so-called *political solutions* invariably fall short, for there is inevitably the next crisis to contend with.

Therefore, those today-realities should literally scream to us that, collectively, we *must have gotten it completely wrong* for a very long time! And we have!

Indeed, precisely *because of* the ‘modern’ narratives that are now at the moment driving the Western world into a new and very insidious direction, it is unlikely that we as a Nation --- *even if we could unite with the same resolve* --- will ever fulfil what was once our *special destiny*!

We united against Covid 19, but “Pestilences” and natural disasters do not usually separate people! It is all the other “human stuff” that does --- like “religion”!

In crucial reinforcement, you should *all seriously embrace* this critical fact: That which Ratana *did not find* is the *same* that I was “directed” to seek out and bring back to this land in order to not just complete his Mission, but to further it --- which I have.

However, whether you in the Beehive believe this or not *is completely irrelevant*, for that *necessary furtherance* of Ratana’s Mission is *anchored for all time* in this land through the Work: **THE COMING OF PAKEHA RELIGION!**

As I have already stated, I cannot change my primary life’s purpose any more than Ratana could have! For *only with* that **Profound Discovery** could the greatness of the **Prophet’s Calling** be *completed* and thus *properly understood*. And *only therewith* could the *true spiritual purpose* of the Maori race be *illuminated* in the book ordained for that very purpose!

So, if the authors of this new account really believe they know Maori history as it is *meant to be taught*, then they need to understand the full import of at least one key Maori prophecy! In this case, it comes out of **Ngapuhi!**

“The day when the ‘white thread’ is revealed is the day when Ngapuhi will fulfil its spiritual destiny. The ‘white thread’ will be woven into the present ‘unfinished tapestry’ to complete it.”

The meaning of the “white thread” is that *it is* the awaited **Truth!** This Ngapuhi prophecy thus fulfils the prime tenet of Ratana’s 1924 prophecy that “the faith” would be brought (to Maori) by “other people” (Pakeha). However,

only after its '*establishment among Maori*' through Ratana could the next part be fulfilled, vis-à-vis, "*it will be us who will take the real faith to them*". It was, *through me*, some years ago at the **Frankfurt Book Fair!**

Taking all these factors into consideration, through the Mission for which I was born to fulfil, *spiritually-symbolically* the *entity*, **Ngapuhi**, has therefore fulfilled its *key* prophecy.

In strict concert with **THE COMING OF PAKEHA RELIGION** being the "white thread": As its ordained author, do I believe Maori will be *spiritually astute enough* to make the necessary recognition and *weave* the content of it into the other two colours to '*complete the unfinished tapestry*'? **No**: I do not!

For despite the fact that a clear thread of Higher Guidance brought all these strands to a time of *ordained convergence*, the changing dynamic of a Maori cultural direction that has *elevated* Tribalism to some kind of "spiritual primacy of place" both *in* and, *perversely*, *for* this Nation, will absolutely ensure that *nothing* gets in the way of the *new* Maori narrative! A few hundred years ago, a colossus of science, Sir Isaac Newton, recognised that "the world" could only be "one way". Even by today's scientific parameters, he was far ahead of his time for he clearly understood and stated, *even then*, that in essence:

"*The laws that govern the cosmos are the same laws that govern all life on earth*". That includes the sure outworking for we humans that: Decisions *must always bring* the *commensurate consequences*!

Therefore, under the exacting and *inviolable* parameters of the **Highest of Law**, you politicians have the *greatest of responsibilities* to "get it right". Not just *conveniently so* for special interest groups, or to promote a chosen political ideology --- but *exactly so*!

That is or should be the first duty if one is not to *inevitably suffer* the *consequences* of formulating *populist law* that is *not* in accordance with the **Higher Paradigm**! For under the aegis of that very specific umbrella, "not getting it right" does not just mean perhaps getting voted out of office next time around. No: It means that the sure "reciprocity" for *every* decision made will return to its originator at its precisely ordained time without fail, *greatly strengthened*.

However, to fully understand **How** that precisely-exacting immutable process works, one must be *fully conversant* with *each Law* in turn, and then in their *collective* outworking,

In their entirety, you will not learn this critical knowledge in any institute of so-called "higher learning"! They are not taught there, for they have not been recognised by the "intellectualism" of the academic world!

As you now know, however: *They were brought here, by me!* As you have also now learned, that also resonates with Ratana's prophecy;--- that from *outside* of New Zealand "*...the Truth would come to us*".

Thus, for *this land* and *its peoples*, only by finding those Immutable, thus absolutely Unchangeable **Primordial Laws** could I then write about them in their necessary and *understandable detail* in **THE COMING OF PAKEHA RELIGION** in the first instance! In reinforcement: There you will find them!

Therefore: As well as the book being part of that fulfilment for this *Nation of different cultures*, so also is *this Statement* to you at *this precise point* in human history where, increasingly, more global societies begin to undergo what is trending towards catastrophic collapse. Even though some 2008 politicians did send personal acknowledgement and opinion, most, as expected, ignored it. To the detriment of the path we as a people were *ordained to travel*, the crucial **Message** was completely missed!

So much so, that in the *intervening* time-period of 9 years to the present, there is *no way* that *any politician* can say a better world has emerged in the diverse societies around the world. Therefore, *during* that 9-year time-period, *politicians*, irrespective of persuasion and/or Nation, have *not succeeded* in producing any kind of "better world".

In obvious truth, therefore, even with the combined global efforts of what too many politicians strangely and perversely believe is their "astute political acumen", all that has been *collectively produced* is a world ***much worse off!***

Even with Peace Accords, Climate Change Agreements, Nuclear Proliferation talks etc., what we have witnessed in those 9 years is an *increasingly rapid deterioration* of virtually *every parameter* of human life and aspiration.

Perhaps the most distressing aspect of our human arrogance is the shocking tragedy of rapid wildlife habitat and species decline on a scale unimaginable even just 50 years ago! If there is anyone out there who would disagree with that fact, then one can only say --- How sad! How blind! How stupid!

Unfortunately, the “human” influences that have wrought this reality will not be stopped now, for there is not anywhere near the political will and ‘guts’ to *force* a “turnaround” sufficient enough to make a real difference. And all the street protests in the world will not *now* prevent the inevitable!

“Ten men will take counsel, and it will come to nought!” -- Isaiah!

A sign and statement from the Great Prophet *for our times*. A case in point: The Security Council of the supposedly “United” Nations.

A case in point also: The constantly shifting landscape of the incredibly adept **Coronavirus** has really shown us how truly stupid many politicians are. Disbelieve the reality of it, or ignore it, and perhaps it might go away. Better yet, *legislate it out of existence!*

We in this land are thankful that, overall on tackling this Pestilence, you in the Beehive in Wellington made good political decisions, from which --- so far --- we are the envy of the world.

In strict concert, however, if we are truly “*spiritually awake*” and not just politically or even *socially* savvy --- for that will not work in any shape or form at this critical time in the history of the human race --- the very *state* of Planet Earth and its societies should *surely tell us* that *all the decisions* we have *collectively made* for a very long time must have been wrong!

Otherwise, in simple yet brutal logic, they would not have brought us to the verge of global collapse across-the-board! In that regard, in one new area of human “stuff”, an obvious question: How is it possible that the global masses cannot see this clear reality? What we see in its stead is every shallow and crass social media platform where millions of the gormless reveal their inane and pointless, superficial idiocy? It is like Nero, “fiddling while Rome burns”! It is, in fact, Kierkegaard’s great recognition that:

*‘It is not the truth that lies with the masses but the untruth.
The crowd is the untruth’!*

Despite the reality of being gifted **Truth** so many times over thousands of years, diverse “crowds” of ‘humans’ nonetheless clung to “their narratives” --- their “untruths”! To ensure their supposed credibility and primacy of place, any opposition to them simply had to be neutralised. That process continues to this day, but in one area of “human stuff”, with a particularly vicious brand of “religious enforcement”!

All that is not helped by the across-the-globe promotion of “Human Rights” --- which nauseatingly translates to “My Rights” first --- *before all else*. Of course, in the clear reality of increasing numbers of global communities suffering escalating exploitation and terrible harm, *they* should certainly be accorded “helping rights”. That would fulfil the great Admonition to “*Do for others...*”

What is flawed here, however, is the apparent *non-understanding* that it is **not** “rights” that in the *first* place should take precedence, but “RESPONSIBILITIES”!

For under the aegis of all the great **Teachings** given to mankind, the *same* **Laws/Rules for Life** are evident in *each*: That “Responsibilities must precede rights”.

To recap: Those Creation-Laws of Life were precisely what **Ratana** was *looking for* to bring to this land. They were not here! In accordance with my life’s primary purpose, I was “graciously guided” to find them.

Understand this, however: **The Laws of Creation**, issuing as they must from the **Very Highest Realm**, can therefore *never* be transgressed *with impunity*. **FOR THEY ARE THE FINAL LAW!**

Einstein’s wonderful definition of Senility:

The legacy of the great **Truth-Bringers** is therefore this:

The resultant tragedy for “not heeding” those great Truths is thus ours alone. The clear truth that *Decisions produce Consequences*, and thereby, *We Reap what we Sow*, are easily recognisable *earthly expressions* of the **Great Creation-Law of Reciprocal Action!**

That immutable and unstoppable **Law of Reciprocity** is now returning to us thousands of years of serious, but ultimately *inexcusable*, transgressions against *all* the **Laws of Life** --- that means *every nuance* of *every human law* that we have ever legislated, and thereby “legitimised”!

Do not now be “politically clever” and deem this **STATEMENT** irrelevant, *religious* rubbish. Ongoing global political denial of clear and *obvious realities* is precisely **WHY** complete societal collapse is now our *inevitable outcome*! The ever-mutating **Coronavirus Pestilence** has more-than-helped shown us that **Truth!**

For what we all see in 4K high resolution every single night is imminent societal collapse, where in place of answers are endless protest marches and anger, religious strife and killings, beaten and shredded bodies, and the great, *ultimately stupid*, never-ending question: **WHY?**

The real question is: *How is it possible that the millions of angry they, cannot see what is clearly self-evident as the ultimate cause of global anguish?*

Now in this decisive year of 2021, from out of a new kind of ‘protest movement’, a very different and rapidly developing *threat* has emerged to *stalk* the entire Western world. This insidious menace vociferously targets even genuine and “spiritually-responsible free speech”. Note that I said “spiritually-responsible free speech” --- thus plain and truthful logic.

So swiftly is this landscape changing that under the new tyranny of “cancel culture”, well-known authors are now subject to abuse and vitriol not seen even just at the beginning of the year. From an online article:

“High profile authors targeted include author J.K. Rowling, Jordan Peterson, Jeanine Cummins and Julie Birchill, and there are plenty more, many of whom we have never heard of. Some are deemed to have committed worse crimes than others, resulting in anything from mild censorship to accusations of insensitivity, cultural appropriation, misogyny, racism or transphobia, while others have had their book contracts revoked --- and writers must learn to navigate this moralistic new world.”

Will this be the new norm for our country as well? If so, where might *this Statement* fit in current New Zealand law? Indeed, where might it fit under that kind of “cancel-culture” regime? Mutual respect for differing views, once readily acceptable, is now perversely under serious threat from new and far less tolerant Western “social-agenda” goals!

This developing trend of *irrational* reality has shown us that in the rapidly evolving global movement of “anything goes” and “everything” is allowed to be, it has now very strangely become dangerous to have an opinion *different to that* which “legislation” has already decreed “is the right way for all”!

So much so that in terms of our indispensable but mostly very ordinary everyday human bodies necessary for life on earth; under this pervasive *new political and social-engineering* umbrella, even views that nonetheless absolutely resonate with precise and unchangeable biological parameters, have now become perilous to voice!

That is despite the obvious fact that those *perfect processes* have decreed the very DNA which, *logically*, brings forth *each* specific life-form and, in its development, gives each one its singular perfection of form and purpose!

So on the one hand we have completely unchangeable, biological processes that have “produced” perfection of form and purpose in *all* creatures on planet earth and have done so *since the dawn of life on it*. Yet on the other we have human beings who perversely still somehow want it to be different. In the strangest of incongruities, perfectly clear biological realities seem to be completely lost on many Western politicians in this 21st century.

Instead, bury what is eminently logical and in its place pander or grovel to the new rapidly-evolving ‘movement’ that not only *threatens* once-standard views, but seeks to *punish* anyone who will not fall into line with *their agenda*! In the process, use high-sounding ostensibly-altruistic ‘human rights’ jargon to get your way, so that *everyone else* bows to it.

In concert, therefore, a critical consideration: Will this growing chorus of vociferous intimidation induce nervous politicians to enact legislation to prevent any challenge to the stated agenda of this new “social order”? For by such weak political acquiescence, *they* who *agitate* for *pernicious change* would virtually be permitted to *rule society*! What would unarguably then be a ‘new dark age’ would, by its very nature, *demand* the *neutralisation* of what are --- in serious reinforcement --- absolutely unchangeable, biological realities, to which the rest of the populace would have to submit. True “freedom of speech” would become more of a *crime* than it is even now!

By way of example, the Government of Tasmania became the first in the world to introduce legislation whereby the sex of a newly-born does not appear on the birth certificate. The question that surely arises is: Why didn’t the attending doctors simply refuse to obey such an insidiously-draconian ‘law’? For they are the medical experts who in at least most hospitals examine all new-born to ensure that they are healthy and *exactly formed* according to unchangeable biological parameters! And therefore, quite obviously, *readily identify* the gender of all new-born by --- guess how --- yes, you got it, *the baby’s sex organs*.

Is that not truly amazing! In truth it is so absurd as to be laughable! Do politicians not look in their mirrors to see “what they are”? What kind of politicians would debate the issue of the sex of a new-born to a point where such truly ‘mad legislation’ becomes the ‘law of any land’?

How much further will primarily Western ‘law-making politicians’ carry this very spiritually-dangerous trend? Will it continue to where this newest and most insidious social-engineering concept brings us to a point where *all* “genuine freedom of speech”, *all* logic, is subsumed by what would unarguably then be a society dangerously close to a kind of *dictatorial totalitarianism*? For if it is not tempered by even just a small amount of *natural logic*, then the ultimate goal would seem to be *subjugation* of mostly, in the end, weakly-acquiescing masses!

In what now seems to be an unstoppable, rapidly-growing social-engineering objective, politicians in more and more countries are enacting more and more of what is ultimately dangerously-deceptive legislation, clearly designed to *force change* in the very thought processes of whole populations. Two well-known twentieth century dictators, through programs underpinned by incredible evil, did exactly that.

Today, a different kind of political tyranny, driven primarily by women *demanding equality across-the-board*, to the ludicrous point of legislating for public toilets to be “gender inclusive”. (Joe Biden’s Executive Order, for one).

It is worth noting that successive American administrations before this present one, publicly held to a ‘dictum’ first stated by President George Washington.

“Above all, the pure light of revelation has had an influence on mankind and increased the blessings of society. It is impossible to rightly govern the world without God and the Bible.”

The fact that a Bible sits in New Zealand’s Parliamentary Chambers, upon which at least some of you probably swear fealty, clearly means that our founding settlers certainly thought the same as George Washington --- *as did the whole line of Maori Prophets to Ratana!*

Biden’s ‘people’ have certainly ‘loosened those reins’ somewhat. Have we seen any *increase* in “*the blessings of society*”? The emergence of the obscenely wealthy ‘one-percenters’ says no! We should therefore ask ourselves what the *real influence* is that is driving this unprecedented “social-engineering” direction. It is clearly not **Higher Inviolable Law!**

The American Constitution, based on the Iroquois Nation’s Code of Law brought forth a country that really was ordained to be an example for a truly “free world”.

America’s great high point came with its mobilisation of millions of its people in the Second World War to fight a monstrous evil! Today, it is a rather mad, paranoid society riven by problems seemingly now too overwhelming to solve. America did not fulfil its “spiritual destiny”.

In response to Biden’s Executive Order, a sudden, back-tracking, jarring rethink --- by *women*, of course--- quite rightly over the safety of *their* daughters who would be in a place where men simply *should not be!* Those were once the rules of a more intelligent world that we are very strangely *leaving behind*.

In addition, if not already in place, the equally unbelievable idea that “changing rooms” in sports complexes and at swimming venues also be included as “gender open”. Perfect places for evil predatory males to flaunt themselves. Should that kind of arrant nonsense *ever* be permitted to raise its ugly head in this blessed land, then the politicians who had legislated *for it* would stand indicted as --- what exactly? There are simply no words adequate enough to describe such outright stupidity!

Man and woman! Necessarily *different*, but each ***perfected to form and function!*** Therefore, as has been “well-recognised” for millennia, necessitating *commensurately-different but very obvious gender needs*. What is so difficult to understand here?

The question **I** ask you *all* --- you in the Beehive *personally* and, *symbolically*, other Western politicians, E.U. politicians and United Nations representatives --- why do you believe you *all* have the *right* to force these kinds of totally illogical changes on the populace? Do you honestly think that you can *all* actually ***legislate against biological reality!***

Since all legislation must first be *voiced in debate* by politicians *before* then being written down to become law, what that process *really* means should *seriously* occupy the minds of all of you, for it derives from the very **Creation-Law** that brought you and me into being! Really knowing the process will automatically induce caution in the use of words --- *before* the mouth is opened to speak.

In truth, whilst parliamentary debate does sometimes in the end produce some “good law”, much of what is televised from the “chamber” is not at all edifying. The following Scripture defines the criticality of the correct use of Language far better than any intellectual dissertation. It is also, in the end, ***biological reality!***

The fact that it is recorded in the Bible as the words of Jesus does not make it “religious” in any shape or form! Great and necessary Truths essential for harmonious life on earth are too often dismissed with the quite silly remark: ***“That’s just religion”!*** So:

“It is not what goes into a man’s mouth that defiles him but what comes out. For what goes into the mouth proceeds to the stomach and is evacuated out the bowels. Those things which proceed from the mouth come from the heart, and they defile a man. For out of the heart proceeds evil thoughts, murders, adulteries, fornications, thefts, false witness, blasphemies. These are the things that defile a man...”

Since the thought must *always precede* every single deed, that simple but inviolable process has wrought the very state of global societies today. Spoken by **One** Whose Teaching roughly two billion humans *claim* they follow and

live by but mostly *do not*, that Scripture stands as the ultimate **Divine Admonition** to speak with *nobleness* and *dignity* --- as was ordained for *all* human beings from the very beginning!

Yet, instead of using this wonderful *gift* of communication in an *ennobled* way, successive generations of Western politicians and lawmakers have overseen the terrible erosion of what were once acceptable standards of language use! Even in peak viewing time, befouled language assails the ears of children and young people!

In this “anything-goes” world, the notion of ‘censorship’ has virtually become an obscenity --- certainly for the many factions that continually demand more and more so-called “freedoms”. Higher standards, or “censorship”: An abomination in their eyes. The very *opposite* is the *actual* “abomination”, allowing it to be so in the first place by lawmakers!

Even so-called “comedy” is little more than smut or smutty innuendo now. Whether a *comedian* or a *comedienne* is onstage spewing forth their so-called humour seems not to make any difference. Both are tarred with the same “toilet brush”, as is the trendy, “supposedly sophisticated”, audience.

So rather than addressing this repulsive trend and turning it around, lawmakers and legislators hide behind the *appalling sham* of “free speech”! Befouled language in “entertainment” now pollutes the whole world. In truth, hiding behind anything is “cowardice”! Incrementally and inexorably, therefore, all “steps too far”!

Since in this area Western politicians have consistently demonstrated the fact that there is little of true “Spiritual Responsibility” amongst the lot of them, calls to bring back “*Spiritually Responsible Free Speech*” have long fallen away!

In addition, the very fact that politicians invariably practice “political horse-trading” to get what *they* want, the whole process is thus one of careful, or cunning, “calculation”! For to simply go along with legislation that is expedient but does not resonate with *genuine inner conviction*, is in the end nothing less than **Hypocrisy!**

Only *honesty* can claim credibility as its commensurate shield.

In the end, of course, it simply will not matter. For as we should by now have finally realised, our time of reckoning really has arrived! So all that “new direction stuff” will have had its ‘short day in the sun’ along with, thankfully and very rightly so, the many global architects of it!

In addressing this *rapidly-evolving global agenda* --- and even with the potential for *political duress* and/or subjugation --- you should know that this **Statement**, sent to you through “sure guidance”, *unequivocally stands* under the overarching umbrella of **INVIOLETA PRIMORDIAL LAW!**

TIPPING-POINT EARTH!

Now considered an existential threat to *all* life, but one not caused by the planet’s wonderful array of wild creatures! After decades of being warned by scientists that we were heading towards ecological suicide but ignored by “politicians” and “big business”; now in 2021 a sudden scramble by especially the worst polluting nations to try to head off disaster.

We, who are supposed to be “intelligent”, *politicise* virtually every aspect of what is really important for the earth and therefore us. The various Nations of the world pass into law legislation to “legally own” their corner of the world and everything *in it* to do whatever *they* want *with it*. Whilst the “sovereignty” of a Nation is a perfectly valid notion, nonetheless, the politics of exclusion in *sharing* resources --- in direct concert with a failing global economic system --- lock into place the terrible disparity of the “haves” and the “have-nots”.

Gwynne Dyer, ‘switched-on’ Kiwi, syndicated columnist, and contributor to documentaries on this very topic, decades ago was the first to *state* the obvious --- *too many people!* Pilloried at the time by religious and cultural groups, some Governments and NGO’s; now others have finally caught up to also recognise that the earth is way past the limits of its ability to provide the commensurate resources for the explosive increase in human “lemmings”!

Yet do we attempt to slow the global birth rate? No, we don’t! The human “emotionalism” that characterises the “save everyone” mentality means that we continue to fight a losing battle for the very health of our earth. For the “corporates of capitalism”, however, a “perfect storm” for their balance sheets and “shareholders”! More people equals more growth, more consumerism --- and *exponentially* more pollution.

Even though *far-sighted* economists have long-warned against this clearly flawed system, with many books now written on *how* and *why* American-style Capitalism is actually *destroying* the planet, strangely and *perversely*, no Western government will opt out of the system.

Why? Because it is not you politicians who ultimately “call the shots”. It is big corporates with their immense financial power and global reach. In some countries, complicit government legislation has also contributed its measure!

All that means exactly what is stated herein: That the *continuation* of the practices which have seriously damaged the earth cannot possibly continue for much longer.

How do we rate in this small but blessed land? In terms of the once *natural balance* of earth’s eco-systems, we are in the *same single waka* as the rest of the world. From Chief Seattle, a relevant section of far greater wisdom than certainly the early European settlers ever displayed in North America under their arrogant, primary Calvinistic, *religious strategy* of “Manifest Destiny”! (Emphases mine).

The great man began his address with the words: **“THIS EARTH IS PRECIOUS....”**

'How can you buy or sell the sky, the warmth of the land?

The idea is strange to us.

If we do not own the freshness of the air and the sparkle of the water, how can we buy them?'

'What is man without the beasts? If all the beasts were gone, man would die from a great loneliness of spirit.

For whatever happens to the beasts, soon happens to man. All things are connected.'

This we know: The earth does not belong to man; man belongs to the earth. This we know.'

'Whatever befalls the earth befalls the sons of the earth. If men spit upon the ground, they spit upon themselves.'

'Man did not weave the web of life; he is merely a strand in it. Whatever he does to the web, he does to himself.'

'One thing we know, which the white man may one day discover --- our God is the same God.'

'You may think that you own Him as you wish to own our land; but you cannot. He is the God of man, and His compassion is equal for the red man and the white.'

The earth is precious to Him, and to harm the earth is to heap contempt on its Creator.'

Contaminate your bed, and you will one night suffocate in your own waste!

Where is the thicket? Gone. Where is the eagle? Gone. The end of living and the beginning of survival.'

In that moving address may be seen elements of Ratana's Mission. By virtue of the directive for the Maori race to be "*my footstool upon the earth*", he would have well-understood certainly most of those principles. Human history has produced many such greatly-enlightened men as Chief Seattle, yet the end result is always exactly the opposite of what they all gave for us.

Today, a terribly degraded and poisoned earth and the scourge of *plastic*! New Zealand "lawmakers": Do the right thing here! Stop point-scoring, and *collectively* do a good thing for this land **right now!**

Whilst certain kinds of plastics are an essential part of society, at the very least legislate out of existence what we really do not need e.g., the *tens of thousands* of plastic trays supermarkets use *every single day* --- and *concomitantly legislate* for the use of already available alternatives. No need for debate, or feasibility studies --- just do the *right thing now!*

We have all seen terrible images of countries where the rivers and coastlines there are veritable waste-dumps of plastic and household rubbish, and little enthusiasm or incentive to "clean them up"! Make *this* land really "clean and green", not how we sometimes falsely present it to the rest of the world!

THE NURTURING OCEANS:

And you, the **GREENS**: Do what *you promised* pre-election, and push for legislation to ban --- in our waters at least --- the terribly destructive fishing method of, now, "deep sea" bottom-trawling! Except in marine reserves, the shallow seas have already been *trawled to destruction*. Over 30 percent of the world's reefs, so far, have been obliterated. Thousands of years in the making and all a visual delight yet destroyed in *one pass* by human arrogance and greed.

It is difficult to understand why successive New Zealand Governments --- both sides of the fence --- have never brought this appalling practice to an end long before now! For "bottom trawling" is not only *ecologically indefensible* but in the long-term makes no economic sense for it impacts the ocean-floor environment so destructively that thereafter its productivity is effectively destroyed. Put simply, that is sheer lunacy!

The "By-Catch"

Under the infallible aegis of the **Highest Law** and thus **Reason**, to take from the bounty of "Mother" Nature's oceans (the domain of Tangaroa) and then throw it back in "Her" face makes no sense whatsoever. (*In my Maori upbringing, such "behaviour" was **Tapu** to all ancient "Lore"!*)

Managing fish stocks is clearly vital, but to then legislate to "force the dumping" of marine life that does not "fit the quota" is not just stupid, it needs to be recognised for what it really is --- an act of criminal, eco-vandalism. Documentaries on this very practice internationally reveal the huge gulf between those who actually *fish the seas*, and the bureaucrats who legislate to *prohibit* the landing of fish species "outside the quota".

In addition, **N.Z.** politicians; show some *real* mettle and really stand up for our oceans. *Loudly condemn* the incredibly cruel and sickening practice of the harvesting of sharks, primarily by **CHINA**, just for soup! And if it has not yet been addressed, *outlaw* the sale of 'shark-fin soup' in this land. Cutting off the fins and callously discarding them means the sharks die a slow death. Annual harvesting numbers now stand at a completely unsustainable 90 million. The real insanity here is that *without sharks*, oceanic eco-systems will inevitably suffer catastrophic collapse.

Just as we stood up against nuclear testing in the South Pacific, be "*the mouse that roared*" here too, and "lead the world"!

MAORI PARTY politicians, even though only two in number, these are the *kinds of issues* you should be seriously addressing, not pushing what seems to be a Maori agenda to "own" everything! Take a very large leaf out of Chief Seattle's "**Spiritually-Ennobled**" address and push for the right "Spiritual" outcomes --- for all people in this land! If you do not, then you cannot, in any shape or form, label yourselves as "kaitiaki" --- of anything!

If the rest of the world chooses to "*suffocate in their own waste*", so be it. In terms of the "*team of five million*", we should never have to! In the light of a global human agglomeration exceeding seven billion that is "not in good shape", a **Source** of certain surety forcefully defines the above realities!

That Source is **Isaiah**, the **Great Prophet**, for he not only describes what is *already now occurring* on a *once-pristine* earth that we have pillaged and poisoned, but what will inevitably be a *thoroughly-deserved outcome* for the *greater part* of global humanity.

The “Earth” mourns and fades away, the “World” languishes and fades away, the haughty people of the “Earth” do languish.

The “Earth” also is defiled under the inhabitants thereof; because they have transgressed the “Laws”, changed the decrees, broken the everlasting covenant.

We can especially apply those three indicting warnings to the very time for which they were prophesied --- our time right now! For our “transgressions” just against the **Laws of Nature** have brought us to the very brink of planetary destruction. Any sacred Covenant to ‘protect and nurture’ that we might once have made, we have surely ‘broken’! Isaiah’s, “*therefore*”, reveals what will inevitably be the end-result of our foolish “transgressions”!

‘ Therefore has the curse devoured the “Earth”, and those that dwell therein are desolate; therefore the inhabitants of the “Earth” are burned, and few men left. ’

Too **religious** for some of you, is it? In this so-called modern day and age, there are surely many narratives that would mock Isaiah’s last sentence. They would be those of prideful *politicians*, prideful *intellectualism*, cultural pride of law/lore, and the many religious histories that condition the diverse global flocks of “believers”. For according to some “expert” Bible “scholars”, the series of prophecies outlined here supposedly foretells events of Isaiah’s time.

However, it must be understood that they are actually directed to **our** world in **our** time today. For it is clearly the “earth” that *Isaiah sees* in his visionary prophecy, *not* the land of Judea. What he actually prophesies, people, is the activity of **Plate Tectonics** and subsequent devastating earth movements --- exactly as the earth experienced during recent earthquakes and tsunami, vis-à-vis:

*‘The “Earth” is utterly broken down, the “Earth” is clean dissolved, the “Earth” is moved exceedingly.
The “Earth” shall reel to and fro like a drunkard, and shall be removed like a cottage; ’*

Those words were *written* 2,800 years ago! Yet science has confirmed that the 2011 earthquake off the coast of Japan was so powerful, ‘*it shifted the earth off its axis*’. It ain’t rocket science, and it is definitely “not religion”!

In 2021, in the twilight of what we have always held to be our “proud rule”, that is what we of the human race have “achieved” for ourselves. Under the shroud of *inescapable global reciprocity*, what Isaiah saw for this very time; in its *fullness* of *ordained reciprocity*, that is what we therefore await.

That immutable outcome brings us to the heart of this **STATEMENT** and, in accordance with the **Mandate** of **Ratana** as the **Appointed Prophet** for **New Zealand** and *also* of *that* which you are now reading; the crucial need for **Correct** legislation in all things --- at least for this land!

As we now know, and even despite his High Calling, Ratana *did not* Recognise an especial reason and purpose of and for his Mission. He only knew that he had “missed something”! It is interesting to also note that Gandhi, shortly before his assassination said: “I missed my guru”!

Two men, a **Prophet**, and a **National Leader**, living at the same time-frame in the 20th century, both strongly *recognised* that they had *missed something*! Now, in explicit concert: The strength of any “genuine Spiritual Intuition” you may or may not possess will determine how *you* “receive” this next crucial revelation. For only with that critical recognition --- which in any case translated to the actual **Event** in the 20th century --- can two other crucial Scriptures about it be completely understood. And only with the correct recognition *of them* will there be *any hope* for at least *some* of the human race to survive what is inexorably approaching! One is the warning prophecy of Isaiah that we have already noted, where we humans have for too long:

transgressed the “Laws”,

changed the decrees,
broken the everlasting covenant...

In concert with Isaiah's clear warning to us in this 21st century --- and noting the fact that this country's foundation was *once* strongly based on Christian Church and Bible values --- before I make clear the revelatory *portent* of the two Scriptures alluded to, in the light of a '**World in Crisis**' the notion of a 'Judgement on humanity' that is present in *all* religious teachings needs to be clearly elucidated.

Firstly, the too-widespread concept within religions that a Creator Being "causes" human suffering is as silly as it is impossible. Despite the reality that *no one* gets away with "**transgressing Creation-Law**", there is no 'finger of judgement' that appears out of the sky to randomly or arbitrarily "zap" human beings. That is a really dumb idea!

For what many religions refer to as 'Divine Justice' must inherently be that, *without deviation!* And only by really understanding the nature of **Divine Justice**, might we then begin to similarly understand the *seemingly* incomprehensible reason/s why the plight of increasing numbers of our fellow citizens is so dire! For to believe that such Justice might somehow be unfair is not only foolish but brings neither understanding nor resolution!

So how does it work? It is as simple as it is Perfect. Whether we suffer or whether we do not is absolutely dependent upon our free-will decisions. They "return" to us the reciprocal effects of "everything" we *send out*. In a nutshell, that is how it works. However, to understand every *nuance* of every *detail* of the, in any case, unstoppable outworking of the **LAWS** (plural), one must first know them all, for only with that *complete knowledge* can Perfect sense be made of all the issues we struggle to understand.

To further *your* understanding here, I strongly suggest that you now set aside any scepticism you might have, preferably try to open up your spirit --- or at the very least your mind --- and *fully engage* with the next two Scriptures.

For if you are *truly awake* you might just *see* what only *a very few* recognise --- usually with *open-mouthed astonishment!* The two billion humans that make up global Christendom certainly have not, so their great "official Christian narrative" continues to terribly mislead them!

Firstly: **John 16**, which states a prophecy by **Jesus** to **His** disciples that: "*When the Spirit of Truth comes, He will lead you into All-truth ...*" --- **He**: A personal pronoun! That very obviously means: **He** --- *not Me!*

Secondly: **Revelation, Ch.1, Verse 4**, and part of **Verse 5**. Now in order to "see" what is really there, in the first place *each line* must be read *very carefully*. In addition, the position of the conjunction --- **and** --- must also be seriously noted. (Emphases are mine.)

*"Grace and peace to you from Him Who Is, and Who was, and Who is to come, and from the seven spirits which are before His throne, ⁵ **and** from Jesus Christ..."*

Apparently straight forward and conforming to the 'official' global Christian 'doctrine'. However, if we now completely dispense with that narrative and take a hard and very objective look at this critical Scripture, we will recognise that in its simple but nonetheless profound clarity, it is ultimately for the *whole* of the human race.

Firstly, it is assumed by supposedly erudite Bible "scholars" that the **One** Who is **Enthroned** must be **God**, because Jesus is there with **Him**. In addition, there are seven spirits *before His Throne*. Then there is the conjunction, "**and**", which separates **Jesus** --- who is clearly "not Enthroned" --- from **Him Who is Enthroned!**

On the surface it is more or less understandable how the official Christian narrative has never been questioned by the faithful. However, in the case of the thousands of "expert interpretations" offered up for well over a millennium, what is a singularly-dreadful error is inexcusable!

For that non-recognition of Immutable Truth has held over two billion "believers" --- the followers of their church "scholars" --- to a path that leads them in the *opposite* direction to where they all think they are *really* heading!

So: What is this appalling error when the Scripture *seemingly reads* as **Jesus** being in the presence of **God** --- **Who is Enthroned?**

The singular key to correctly understanding that it is not the Creator Who is Enthroned there, is the fact that other Bible Scriptures unequivocally state: "*No man hath seen God at any time.*" "*No man has yet seen God.*" Since the whole notion of a vast Creation needs to be understood as a "Work" brought into being through the formative Power of "Creating", the **Master** of that humanly-incomprehensible **WORK** must naturally reside *above IT*.

So the very *fact* that John the Revelator can actually *see* the One on the Throne obviously means that **He is not God!** In addition, further on is clarified the fact that a "host of human beings" are assembled in front of the Throne, who therefore can *also* see Him! So, "Who" is He, if He is obviously not Jesus the Son -- and He obviously cannot be the "unseen God"?

Right there is the great error that clarifies the very heart of Isaiah's "*Few men left*", and Jesus' "*...for there shall be destruction not known since the beginning of the world nor will ever be known again, and were the times not cut short not a man would be saved*".

So the "Judgement Day" characteristic that the *three* monotheistic religions of Judaism, Christianity and Islam teach as a *non-negotiable tenet* where we are all "externally targeted", is completely wrong! The Judgment aspect, *already occurring*, is so because the **Laws of Creation** --- *Immutable* and thus *Inviolable* --- were anchored on earth in the 20th century by **He Who** was to Come --- **He Whom** Ratana missed.

So, taking the two key points into consideration: 1), the Perfection of **Creation-Law**, and 2), our inherent, human free-will attribute; the simplicity and Perfection of **Divine Justice** is thus revealed. Under the sure outworking of **THE LAW**, by our thoughts, words, and deeds, we human beings therewith “judge ourselves”! And that is surely **Perfect Justice!**

To that end, the rapidly unfolding, increasingly dire, events on earth clearly resonate with the saying: “*The Proof of the Pudding is in the Eating*”!

Quite obviously, the clear ramification of those prime prophecies of Isaiah and Jesus necessarily means that exceptionally powerful but in any case perfectly natural catastrophes will *bring to fulfilment* the reality of “few men left”! In this 21st century we are just at the *beginnings* of that now *unstoppable process*.

To demonstrate in real time one of the *effects* of the prophecy of Jesus right now, the first part of that Scripture is forcefully directed to the women of the present—day, vis-à-vis; “*Woe to the woman who is with child in the last days, and to those that suck at the breast, for there shall be destruction...*” etc.

In just *one* example of the *strength* of that prophecy, we can turn on any news channel any hour of the day and see horrendous footage of hundreds of thousands of women who are *with child* or who “*suck at the breast*” crowded into squalid refugee camps having fled conflicts and atrocities of one form or another visited upon them mostly by gun-toting gangs of uncaring thugs --- the dregs of humanity.

At many breasts, often terribly malnourished babies, even very young children. Who should take the *ultimate blame* for their dreadful plight? Despite the reality that other human beings bring about such dreadful situations, as we have elucidated, the true and ultimate answer to that question and all similar kinds of tragedies, will never be found in *human* notions. That is precisely “why” the state of human societies is so dire.

So: Do we really want to know Why, or do we just continue on the current path that is clearly *not working*?

The final connecting link to these threads lie in the second part of the Scripture of John 16 of “When the Spirit of Truth Comes...”

“*And He, when He comes, will convict the world concerning sin and righteousness and judgment...*”

Of course, there are disagreements over what in any case are the clear connotations of that prophecy, from other religions to begin with, but also from within the Christian Church itself. However, every single objection to its nonetheless clear meaning can be completely negated from other “clarifying” Scriptures! There are no gaps here!

That is precisely why no government no politician, no religion, can change what is already upon us. We are all simply going through the motions and, under the great **Law of Reciprocity**, forced to experience all that we have brought on ourselves.

So all you and every other politician in the world can do now is institute just small, short-term outcomes, for the really big and final ones have been taken out of human hands. -----

Watch this space, for it is going to shake the very foundations of all that we have foolishly believed to be correct!

The whole “**Proclamatory**” thrust of this Statement clearly presupposes that I have access to the extensive writings of **He Who came**, and that is correct. Therefore: From ‘**The Last in the Line of the Maori Prophets**’; you should take that underlined sentence as a *prophecy* in its own right.

In direct concert, notwithstanding Ratana’s wonderful mission in showing the direction we were all *supposed to take* --- not through a “religion”, however, but as a “spiritually-united” people --- we must nonetheless “put right” two serious errors he made!

The first is the use of the **A** and the **O** --- the **Alpha** and the **Omega**, the **Beginning** and the **End** --- to name his two sons. Why is that so serious? It is because the *actual Alpha and Omega* was **The Very One Who** was present on earth in the 20th century and **Who**, in a terrible irony, Ratana was “looking to find”. That is why I have been *directed* to bring this *fact* to *your* attention. If this Truth is problematic for you or the Ratana Church, it cannot ever be changed.

The **A** and the **O** on Ratana’s “Whetu Marama”, on the other hand can be seen as a connecting link to higher Realms, for the very *foundational-essence* of both the symbolism and meaning of it is that of **Inviolable Creation-Law Truth!**

The second great error is inexorably “bound” to the first. In 1939, Ratana’s “Final Covenant” included two prophecies about the “return of Jesus”. From “Ratana Revisited...”, this small excerpt is from the first. The second prophecy was given at the same time.

“*Oh, Lord Jesus Christ. Come now, and rule over all the people,...*”

“...That we may prepare ourselves for Thy coming Kingdom, when it comes to this earth, fuelled as it will be from the powerhouse of your Divine Spirit. We await Thy coming, Lord God, in all Thy Glory! When we, your true believers, will know our reconciliation with Thee, through the reigning grace of Jesus Christ, Thy beloved Son and our Saviour! Hallelujah, Lord! Yes, so shall it be.”

Ratana’s petition was not granted, for it was *not* Jesus Who came! *He Who did* was the *actual* One prophesied --- “As a thief in the night”! And only “the few” recognised, also exactly as prophesied. As I stated earlier, had Ratana

“found” **The Alpha** and **The Omega**, you would not have needed to receive this **Statement** from me! That is why --- for this land and its people --- I was *directed* to complete Ratana’s Mission: To **Proclaim** what he did not find.

Despite those unfortunate aspects of **Ratana’s Prophetship**, the fact that there was **always** meant to have been a higher purpose for **this land** and **its peoples** *has not changed*. Regrettably, we have not fulfilled that Ordination!

The Christian heritage that marked the *founding* of New Zealand occupies the same position as the rest of Global Christendom. The increasing problems facing humankind are seen as signs that herald the *imminent* arrival of Jesus as the Messiah! The whole Christian system is so locked into this dreadful mistake that even university-trained theologians cannot see what is eminently logical in Rev. Verse 4/5, yet the very Scripture literally screams it to the heavens.

In addition, every other religion is waiting for a *different* Messiah and, of course, ‘he’ must conform to *their* human/religious “requirements”! How strange is that?

Equally strange, if viewed brutally-objectively, is the apparent belief of the approximately 3.7 billion global monotheists of Judaism, Christianity and Islam that “their God”, or *their* notion of a Creator-Being is seemingly perceived as the *highest* of what it means to be *human*, and that therefore *they* will one day be in **His** actual presence! Yet that is despite the fact that *all* three religions possess the same tenet; that there is a “separation” between man and God.

The same also want “their god” to be a “god of love”, for them, solely. In their eyes, a God of Justice is O.K. as long as He punishes *their* enemies, and not them. That strange and obviously unworkable posture is really nothing less than **HYPOCRISY**!

Yet despite over a thousand years of exposure to the highest Truth, *all three* have missed the second greatest moment in the history of the human race. Simply believing their individual narratives cannot change what now is! Not even bowed head and handwringing false piety; for unless correct recognition is made in time, *all* errors and untruths stand as exactly that --- forever!

The prophesied **All-Truth** of **John 16** has now been on earth *in written form* for almost one hundred years. It has been translated into nine languages so far, which means many tens of thousands across the globe have recognised its profound nature.

Unfortunately, the **All-Truth** being exactly *that*, means that **IT** has suffered persecution, been banned at various times in some countries, with confiscated copies publicly burned. Yet even the **Vatican** has a copy in its archives. In addition the most *senior members* of that hierarchy are aware of **Who** the author **IS**, but because an open admission of **Him** to their one billion followers would mean the *end* of the very carefully-nurtured Catholic narrative, that critical fact will *never* be made known to the “church-faithful, too-trusting, sheep”!

Moreover, whilst many of the thousands of Adherents of the **All-Truth** --- from *all* walks of life and professions --- *could* speak out publicly to *their* governments, they do not. Surely: The Truth is *anathema* to the human world of this 21st century!

So much so, that in a world now seriously out of kilter, the growing virulence of mob protests bent on tearing down what were once “traditional societal mores” have instilled disquiet, even fear, amongst most of those who also recognised --- (Isaiah’s “the few”) --- from *publicly* offering comment to *their* “lawmakers”. Unfortunately, that reluctance to do so is to the serious detriment of *their* countries and societies. In any case, would politicians really listen?

Why have I been *directed* to tell you all of this? **It is because no one else will!** Ratana missed it, and I was born to find and thus Recognise --- for this land and its people --- The One Enthroned in Revelation Verse 4 Who *did* bring the **All-Truth** to earth at this End-Time.

If you have not tossed this **Statement** aside by now, the question you will probably be asking is: “*What has this got to do with me or with the business of government?*”

That has already been well stated. Nonetheless, in reinforcement, for this *blessed* and *chosen* land, *you* are *all* meant to know! What Ratana “missed” but at least some thousands in many countries have recognised and also embraced, is precisely *that* which I have brought to your notice herein.

Quite obviously for you in the Beehive, there is no fear element with me over this Revelation! So in accordance with my *primary* purpose for *being here*, you will probably be the *only group of currently elected ruling politicians on earth* to whom a **Statement** such as this is sent! Primarily in which you have been made well aware of what should have occurred in Ratana’s life!

Especially to you of the **Labour Party** with a traditionally strong association with **Ratana**; because you have the numbers, you can “push through” any legislation of your choosing. You are the people who will thus legislate for your ideological mores to be foisted on New Zealand society, and concomitantly determine lawful consequences and legal “punishment” for offences against “*your* law-changes”!

However, under the very aegis of **Inviolable Creation-Law** --- *in written form* by **His Hand** and now **Spiritually Anchored** in this **Blessed** and **Chosen** land --- as global societies undergo inexorable collapse, *you* have the *gravest* responsibility to legislate accordingly!

Not knowing this **Ultimate of Law** is completely immaterial. In sure reinforcement, precisely because of our inherent, singularly human, “free-will” attribute, every decision we make is innately subject to unerring and unswerving, **Lawful Reciprocal Reciprocity!** Therefore, as previously stated, legislate “spiritually-correctly”!

Do that *from this point on* --- before the really great disasters strike --- so that on a *population-percentage-basis* this land and its people will have the *greater possibility* for Isaiah’s “*only the few*” to perhaps be “*relatively many*”.

Here the great paradox, for it is by virtue of the Ordination of a line of Maori Prophets culminating in Ratana that for us *more than most other people*, even at this late stage is really achievable! But only the *possibility*, only if you lead them *legislatively-correctly* --- thus *spiritually-correctly*! Now you know how!

For those of you Parliamentarians who hold to the “official Christian narrative”, these Truths can neither be disposed of by political ideology, nor by any kind of concomitant legislation. For the **Truth** does not beg! **IT** has no need to: **IT** simply **Proclaims!** Only *religions* beg!

All the ancient prophecies have now been *activated* for this 21st century. Activation means “proceeding to fulfilment”! Therefore, firstly in unstoppable reciprocity by humans against humans in every kind of “inhumanity to man”, such as we witness in the surfeit of ‘never-ending’ newscasts.

In addition and wrought *solely* by stupid *human* decisions, the concomitant ramping-up of natural disasters has resulted in the daily unfolding of human tragedy upon human tragedy! That, however, is just the *first part* of what we must undergo, what we have brought on ourselves and *already occurring*!

When that has finally run its own horrendous course, *then* we will experience the Full Power of the **Forces of Nature!** For that Power, too, must obey **Immutable Creation-Law!**

Because *all* political ideologies stand *diametrically opposed* to that **Ultimate of Law**, there is no political manifesto on earth anywhere near “spiritually-ennobled” enough to “save global humanity” from its own stupidity! Even as a *collective* of politicians, scientists and religious leaders; you may all believe you can stay the frighteningly-obvious, but you cannot. For it is precisely the increasing *pressure* of the **Power of The One Law** which is driving and *forcing* rapid change and violent unrest on a scale not previously seen. It has become global in its extent.

That Pressure *thus forces everything wrong in human thinking and deed to reveal itself*, to show its *true face* to the world. By that process, the instigators and practitioners of *all wrong directions* are given the chance to either *change direction* --- or stay on their “chosen” path and *go down with it*!

The “wrong” will not be permitted to continue! Since almost everything that we believe and do is *exactly* as Isaiah prophesied: ---

transgressed the “Laws”,

changed the decrees,

broken the everlasting covenant...

... that is precisely why there is now no good outcome for a major part of the human race. And disbelief will not change by one iota that sure Truth!

So: Be on the right side of Isaiah’s warning prophecy for our time **NOW!**

In direct resonance: What follows are two excerpts from the *complete Teaching* that both Ratana and Gandhi “missed” --- which I obviously possess --- and from **IT**, in clear, unmistakeable **Power**, is *illuminated* the path we of the human race should never have abandoned!

* * * * *

“If in the course of thousands of years men had not *always* acted as they still do *today*, if they had not time and time again distorted everything that was intended to help them, in order to adapt it to their earthly way of thinking and their earthly desires, there would now be only *one uniform* teaching here on earth, issuing from the Will of God. There would not be so many kinds of denominations.

“For all teachings were at one time willed by God, precisely adapted to the individual peoples and countries, and formed in complete accord with their actual spiritual maturity and receptivity.

“...The bringers of all the individual teachings were Forerunners of the Word of Truth Itself.”

* * * * *

Note: “...*the pedestal on which the Truth is to stand*”. Not ‘has stood’. Had we truly “listened” to our **Teachers of Truth** over the thousands of years that each in their ordained time-period came to earth, we might have spared ourselves the historic reality of constant war, bloodshed and certainly religious intolerance and hate.

Thus, the Admonition: “*Do for others what you would want them to do for you*” could have become globally entrenched. But it did not! Thus:

* * * * *

*“Wherever you find intolerance and malice, or even enmity and stirring up strife against others who are not of the same faith, wherever men seek to harm those of a different belief, either *the teaching is not from God* or it has been falsified. And such people serve only the Darkness, *never the Light!*”*

The teaching that permits this *must* be distorted, whatever it is called; for a teaching that has not yet been distorted will also swing in purity in the Laws of God. It does not produce human beings who wish to harm their fellow-men!”

Note the *last sentence*. This country experienced that very thing in the Christchurch Mosque shootings. Harming those of a different belief has been entrenched in the human race for thousands of years. Yet such is the strength of its dark hold over us, that no one will bring the madness to an end. Case in point: America and its endless round of massacres by the gun!

The actual **Author** of those two “excerpts” I will not name in this **Statement**. Suffice to know that it was **He Who** Ratana and Gandhi --- along with *many others of most races* at that exact time in history --- should have “recognised”!

Excerpt from Chapter 1. **The Coming of Pakeha Religion.**

“WHO ARE YOU?” *Know Thyself!*

~ ~ ~ ~ ~

Firstly, the decision to write the book --- (**THE COMING OF PAKEHA RELIGION**) --- was made with the confidence that I am able to bring to it the depth of perspective needed to both clarify and justify the reason for the Title. In short, in pertaining to things **Maori**, to have necessary *ancestry* as the first requirement.

Secondly, to have lived the formative years of childhood in what could generally be termed, today, a “Maori environment”. Thirdly, to have lived those experiences which we would unequivocally state to be **Maori** in essence. And, fourthly, to have the broader, wider experiences in life whereby these various aspects can be brought together in a more objective overview of the subject matter than perhaps a *solely* culturally-dependent or culturally-emotional Maori analysis might offer.

A particular dimension that might allow a deeper insight into our subject is **Military Service**, particularly the **Army** since the Maori were essentially a militaristic race. In the two World Wars it was a source of considerable pride for Maori soldiers to have served in those conflicts, as it also was for the various **Iwi** to whom those soldiers belonged. And if, during the course of such service, one is fortunate enough to visit foreign lands and intimately experience the everyday life of other people, especially *indigenous* or *native tribal peoples*, this deeper sharing adds another important facet to one’s life experiences, particularly in the context of our subject matter.--- (My **Borneo Tour of Duty** experience!)

More deeply felt, however, are the experiences shared with *fellow Soldiers* on **Military Operations**. By virtue of its volatile nature such situations are imbued with far greater intensity than everyday civilian life, and more so when comrades --- to whom one is inevitably strongly bonded --- are killed in the course of soldiering. The volunteer Soldier fully accepts this possibility, however, and adjusts his thinking and outlook accordingly. The *toa* of former times also had to accept such possibilities on a virtually permanent basis, but of necessity, not of choice.

It is my belief that the various aspects outlined here enable me to offer a uniquely constructive insight to some of the contentious problems we face as a *race* and as a Nation. However, since the *wero* (challenge) has always been an inherent part of the *Maori ethos*, I accept that both my assertions and the overall premise must also be open to the same process.

To that end I am sure that many of Maori descent will have heard the question “**Who are you?**” a number of times in their lives: It is usually delivered in a challenging manner. For some Maori it may be important that I establish “**Who I am**”. For me personally, my *Tatai/Whakapapa* is not overly important.

Under the outworking of **Inviolable Creation-Law** --- (that which is the **Foundation** for the enclosed **Statement** and, indeed, for our very lives and reason for being) --- I have no identity crisis within the framework of the racial make-

up of Aotearoa. I am who I am. In the first instance, and thus the most important aspect, I know my **Spiritual Origin**. And in the material sense, all I need do is look into a mirror to see **‘Who I Am’!**

Nevertheless, to satisfy *Maori protocol*, in particular for those who would demand an answer to the question, **“Who are you?”**, my connections to just that part of me which is connected to Te Maori ---i.e., the earthly racial mix of my material/physical body --- in this **Addendum** is recorded in my Tatai/Whakapapa!

Long established in the protocols of Maori *korero*, or discourse, the great question, **“Who are you?”**, in my judgment can be asked in a number of ways.

1. Arrogantly --- as a challenge.
2. Dismissively, implying that one is regarded as of no account --- without any right to speak.
3. With curiosity --- seeking to learn the connections of the speaker and thus relatively tolerant.
4. With genuine interest.
5. With warmth, and therefore welcoming!

In the Maori world of challenge and counter-challenge, the establishment of a *superior negotiating position* is of primary importance. The question, **“Who Are You?”**, is designed to be *psychologically demeaning* in the *first* instance. And, moreover, is very effective if the *recipient* of the challenge is unsure of his personal position or his factual knowledge of a given subject.

Quite obviously, however, chronological age, position or status in a tribe or group does not automatically confer great knowledge and wisdom on any individual. It is therefore *unwise* to ask the question, **“Who are you?”**, arrogantly.

Far better to supplant that question and attitude with words such as: “What is it that you have to offer?”, thus *warm and welcoming* --- in sure concert with **POINT 5!**

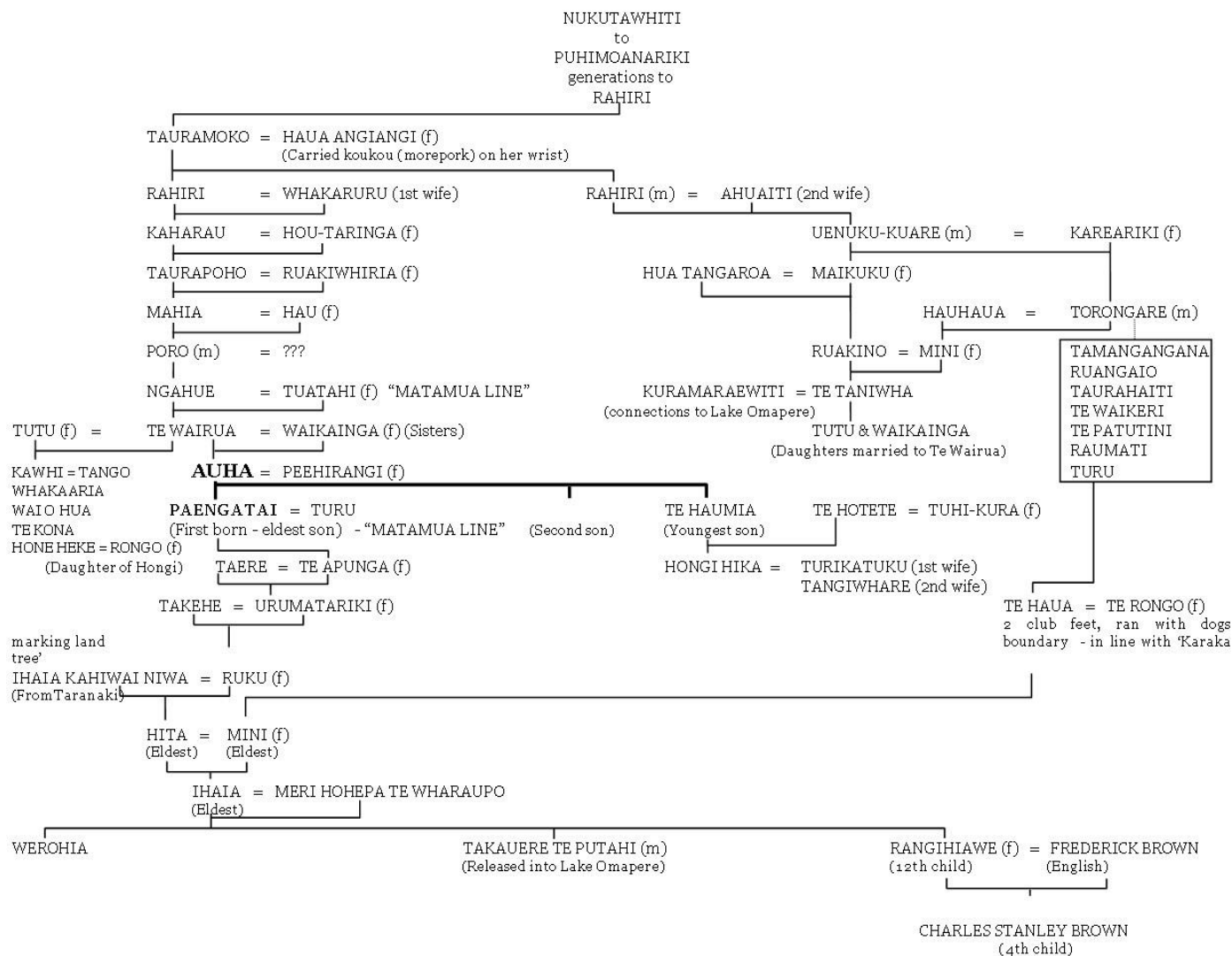
It is my sincere hope that Maori readers of this book will adopt the latter!

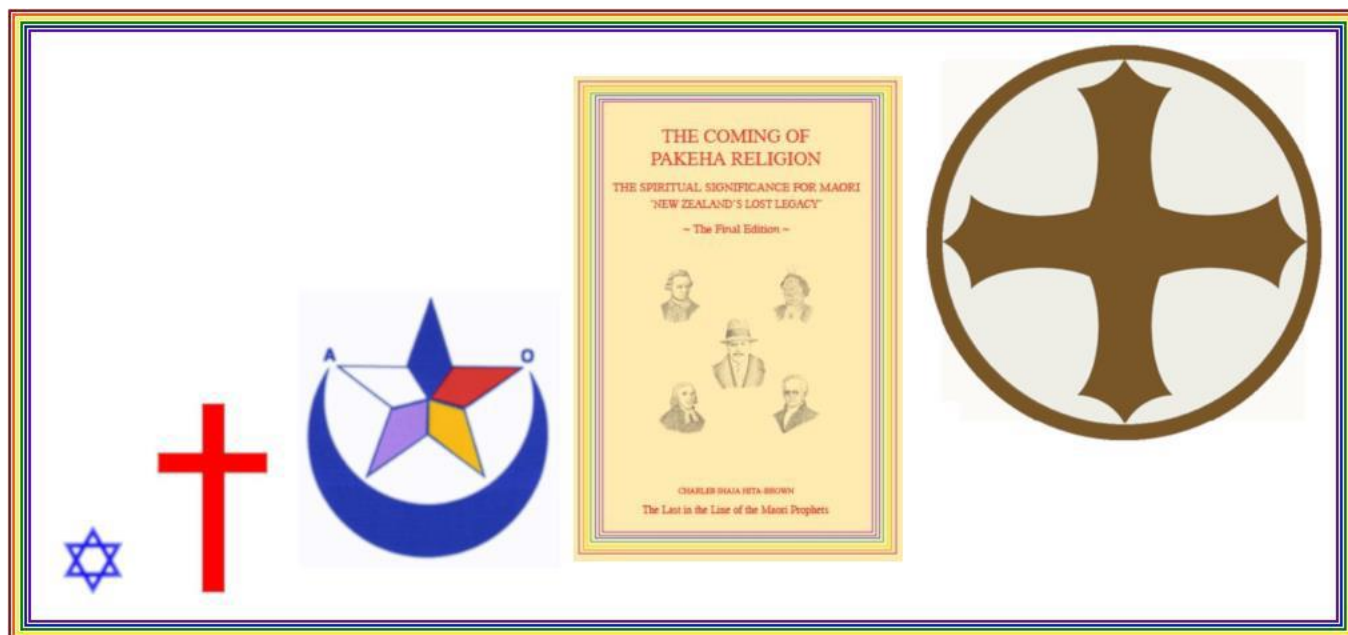
